The price is \$550 and includes ski in/out accommodations, breakfast buffet daily, 3 dinners, 5 ½ days skiing and 5 90 minutes ski /ride lessons. Trip would be on the books and 2 trip leaders would each take a bed comp. 1 bed comp for every 20 people. Any comps after 40 people would be turned back to the Club.
- Proposal was made for a 2010 Drive MTL Ski trip January 31<sup>st</sup> through February 5<sup>th</sup> to Lincoln, New Hampshire. Since the dates overlap with the Fly Trip to Zermatt another week will need to be determined.
- No vote was taken on any of the trips presented. There will be a special board meeting held on Wednesday, May 13 at 7:00 pm to allow the trip to Lincoln, NH to be fully presented with a different date. Drive ski trip will be voted on at that time.
